#### 12 APRIL 1988

CALL TO ORDERThe meeting was called to order at 4:12 p.m. by Board Chair James Brown.MEMBERS PRESENTOther members of the Board present were Tom Brennan, Dorothy Vekich and<br/>Pat Warren. Lee Rhoden was out of town and was excused from the meeting.

MINUTES Tom Brennan moved that the minutes be approved as mailed, Dorothy Vekich seconded the motion, motion carried. It was noted that on page 2, the TRL Director was referred to as "Dr." Dickerson, typographical error noted.

BILLS

S The bills were approved by the Board as presented and signed for payment.

## UNFINISHED BUSINESS

In response to Board questions about weeding and collection philosophies. WEEDING PHILOSOPHY a section of the article "Reference Service as a Guide in Public Library MAGAZINE ARTICLE Organization" by T.D. Webb, from the Fall 1987 issue of Reference Service Review, was passed out to the Board. This article defines the newer POPULARISM "popularism"/circulation statistics "debate" in public libraries as applies to collection development/maintenance. This is a trend in many public libraries. There followed a discussion about reference service and research. It was noted that Mr. Dickerson's memo on the philosophy of weeding was well-stated and a good philosophy, but that the direct application to some materials did not seem suitable. The Board was concerned for the future, as the memo stated that the collection in Aberdeen needs to be 10-15% REDUCTION/ reduced, if one follows a strict formula on collection/demographic statis-COLLECTION AT AB tics. Aberdeen is not geographically situated for great ease of getting

ACCESS TO "RESEARCH" to a larger research facility, especially during several months of the FACILITIES vear when icy roadways can pose a problem for many drivers. Those in the southern Puget Sound area have much more convenient access to the library facilities at The Evergreen State College, the Washington State Library, Washington State Law Library, St. Martin's, and even the Tacoma/Seattle area libraries. Grays Harbor College is making some great strides in collection development, but still does not have the collection extent, nor the hours, needed in this area. Aberdeen residents would have to drive 1<sup>1</sup>/<sub>2</sub>+ hours, wait 2-3+ weeks for ILL, or possibly not be able to even obtain it at all via interlibrary loan.

PLANNING PROCESS RESPONSE BY BOARD RESPONSE BY BOARD The Board was interested in how this philosophy "works" with the planning process now in progress. What happens when the public defines access to information their priority. Who decides what information they will have access to? The Board noted that they were glad that Mr. Dickerson did understand their concern, and decided that a response was in order, expressing the Board's idea of the public library collection and their expectations concerning the same.

NEW BUSINESS

SIGNAGE

Christine noted that the painted sign on the front entrance to the library is incorrect and does not reflect Aberdeen's open hours, which now seem to be fairly "set". The Board discussed the situation and decided that if the style and design of the new lettering is approved by Christine and Jay, it would be approved by the Board.

## CHILDREN'S SERVICES

Christine noted that Joanne was providing a program at Westport and that she had not realized it was the Board meeting when the program was first scheduled. Christine reminded the Board that Children's Services in G.H. County are provided by Joanne being based at Aberdeen 32 hours/week, with 8 hours staffing in the county. Christine reported on Joanne's activities for National Library Week and the Change Your Mind program, which centers ABERDEEN LIBRARY MINUTES 12 APRIL 1988

on reading instead of watching television. Christine also mentioned an interview for the radio over the telephone as part of a panel of 3 on parenting and alternatives to watching television. Joanne has some very good ideas, including one used in Illinois, which is an end of the summer storytelling campfire. The Aberdeen Friends of the Library will provide the marshmallows at the August 30, event at Stewart Park.

Jay reported that the only addition to the written report was the fact that Mr. Churchill's class visited the library 3 times during the month, and that there were about 16 students each visit. James Brown asked about the Medical Reference workshop and CD-ROM information. Jay noted that we had Medline on CD-ROM and a demonstration copy of Cancer information on CD-ROM.

STATISTICS DROP Christine reported that Aberdeen "lost" ½%, from 8.5 to 8.0% in TRL materials distribution. At this point the Board discussed the TRL Comparative Statistics and how these affected Aberdeen.

ANNUAL REPORT Tom Brennan moved that the Annual Report be approved, with appreciation, motion seconded by Dorothy Vekich. The Board voted to approve the report.

<u>ADJOURNMENT</u> There being no further business of the Board, Dorothy Vekich moved that the meeting be adjourned, motion seconded by Tom Brennan. The meeting was adjourned at 5:40 p.m.
