 - A. Certificate of Appreciation Marketing class at North Thurston High School

 - A. Summer reading program funding

BACKGROUND: At the two previous board meetings authorization has been given to seek financial assistance from local foundations for programming activities which are part of Timberland's summer reading program. TRL's application to the Bishop Foundation was not successful, and we haven't heard from the other foundations yet.

Recently it was determined that the Ludlow Foundation in Lacey is receptive to (and has approved) a request for \$900. Since the board needs to be legally involved in each grant request, board authorization is needed for this request too.

RECOMMENDATION: MOTION to authorize the submission of a grant proposal to the Ludlow Foundation to provide supplementary programming assistance for Timberland's 1988 summer reading program.

B. Special meeting for June 29

BACKGROUND: Last month the board members requested that they receive copies of the draft classification plan report well in advance of its presentation at the June 22 board meeting. Martin Kenny has indicated that the timetable is too tight to get the report to people in advance of the meeting. Accordingly, it is being recommended that a special board meeting be held on June 29 to receive the report. This way, the report can be distributed in advance and Mr. Kenny can respond to questions or "postponement" the meeting.
